

# **Just Dating Coin (JDC) Crowdsale: Terms & Conditions**

The following Terms and Conditions (“Terms”) govern the sale of Just Dating Coins (“JDC”) to crowdsale participants (“Purchasers” collectively, and “Purchaser” individually).

This document describes the initial sale in which the Just Dating Coin (“JDC”) is sold. It is not a solicitation for investment and does not pertain in any way to an offering of securities in any jurisdiction. Individuals, businesses, and other organizations should carefully weigh the risks, costs, and benefits of acquiring JDC early in the initial sale versus waiting to purchase JDC on open, third-party exchanges.

## **IMPORTANT**

Ownership of JDC carries no rights express or implied. Purchases of JDC are non-refundable. Purchasers should have no expectation of influence over governance of JustDatingSite (JDS).

By participating in the sale of JDC, you expressly acknowledge and represent that you have carefully reviewed the Terms and fully understand the risks, costs, and benefits of purchasing JDC and agree to be bound by these Terms. As set forth below, you further represent and warrant that, to the extent permitted by law, you are authorized to purchase JDC in your relevant jurisdiction, are of a legal age to be bound by these Terms, and will not hold liable for any losses or any special, incidental, or consequential damages arising out of, or in any way connected to the sale of JDC, now or in the future, JustDatingSite and its affiliates.

**WARNING: DO NOT PURCHASE JDC IF YOU ARE NOT AN EXPERT IN DEALING WITH CRYPTOGRAPHIC TOKENS AND BLOCKCHAIN-BASED SOFTWARE SYSTEMS.**

Purchases of JDC should be undertaken only by individuals, entities, or companies that have significant experience with, and understanding of, the usage and intricacies of cryptographic tokens, like bitcoin (“BTC”), and blockchainbased software systems. Purchasers should have functional understanding of storage and transmission mechanisms associated with other cryptographic tokens. While JustDatingSite will be available to assist Purchasers of JDC during and after the sale, JustDatingSite will not be responsible for lost BTC or JDC resulting from actions taken by, or omitted by Purchasers. Note, in particular, that JDC Purchasers should take great care to write down their wallet password and not lose it so as to be sure that they will be able to access their JDC when it becomes available after the initial sale. If you do not have such experience or expertise, then you should not purchase JDC or participate in the pre-sale of JDC.

## **WARNING: CRYPTOGRAPHIC TOKENS MAY EXPERIENCE EXTREME PRICE VOLATILITY.**

**Just Dating Coins do not represent any formal or legally binding investment. Cryptographic tokens that possess value in public markets, such as BTC, have demonstrated extreme fluctuations in price over short periods of time on a regular basis. A Purchaser of JDC should be prepared to expect similar fluctuations, both down and up, in the price of JDC denominated in BTC or United States dollars (“USD”) or currencies of other jurisdictions. Such fluctuations are due to market forces and represent changes in the balance of supply and demand. JustDatingSite cannot and does not guarantee market liquidity for JDC and therefore there may be periods of time in which JDC is difficult to buy. Additionally, due to different regulatory dictates in different jurisdictions and the inability of citizens of certain countries to open accounts at exchanges located anywhere in the world, the liquidity of JDC may be markedly different in different countries and this would likely be reflected in significant price discrepancies. By purchasing JDC, you expressly acknowledge and represent that you fully understand that JDC may experience volatility in pricing and will not seek to hold JustDatingSite liable for any losses or any special, incidental, or consequential damages arising from, or in any way connected to, the sale of JDC.**

## **WARNING: THE PURCHASE OF JDC ENTAILS A NUMBER OF RISKS.**

**The purchase of JDC carries with it a number of risks. Prior to purchasing JDC, you should carefully consider the risks listed below and, to the extent necessary, consult an appropriate lawyer, accountant, or tax professional. If any of the following risks are unacceptable to you, you should not purchase JDC. By purchasing JDC, and to the extent permitted by law, you are agreeing not to hold JustDatingSite liable for any losses or any special, incidental, or consequential damages arising from, or in any way connected, to the sale of JDC, including losses associated with the risks set forth below.**

## **TERMS AND CONDITIONS**

**1. Overview of Initial Sale of JDC JustDatingSite will produce and market a quantity of JDC in a pre-sale event called the initial sale, to be conducted on its web site at <http://ico.JustDatingSite.com>. (“the initial sale”). Purchasers in the initial sale will acquire JDC in exchange for BTC, WAVES, ETH and ETC at predefined sale prices over a period of forty seven (47) days. Purchasers of JDC in the initial sale will be granted user accounts on the aforementioned website that will enable them to claim their purchase at the end of the initial sale. All JDC pre-sold in this manner will be created on the Waves and Ethereum networks after the end of the initial sale, although there are no guarantees that this will occur within a given timeframe. JDC purchased with BTC, ETH, ETC and WAVES will be created on the Waves blockchain. JustDatingSite will allocate the purchased JDC to the corresponding user account on the web site, delivering it to their control.**

**2. Creation of JDC will be simultaneously issued on the Waves platform and the Ethereum platform. The total supply of JDC will be created on the Waves blockchain. Using a new technology comprised of a web interface, locked wallets and smart contracts on the Waves side, JDC will be dynamically interchangeable from one blockchain to another as the end user wishes. No further JDC will ever be created.**  
**TIMING OF SALE** The initial sale will begin at 00:00:00 UTC on 15 August, 2017. The sale will run for 47 days and will end at 23:59:59 UTC on 30 September, 2017, or whenever the cap of \$3 million has been reached.

**3. JDC Pricing Based on the performance of other recent blockchain project launches**  
JustDatingSite management has determined that this initial sale shall be partitioned and sold at increasing price points as the sale proceeds. Full details about these price points will be provided in a timely manner to Purchasers in the initial sale and will be available on the website at the time of purchase.

**4. Disclosure of Purchases** To enable JDC Purchasers to have as much information as possible to guide their decision-making process, JustDatingSite will disclose in real time the total funds collected in the JDC initial sale to enable the Purchaser to develop an understanding of the size of the existing JustDatingSite funding pool at the time of their JDC purchase.

**5. Purchase of JDC from the JustDatingSite Website** will maintain a store interface, which can be used to purchase JDC. The store interface will be available on the JustDatingSite website (<http://ico.JustDatingSite.com/>). Instructions for purchasing JDC with BTC and other cryptocurrencies using the store interface will be embedded and available for review on the JustDatingSite website during the duration of the initial sale. Failure to follow these instructions may limit, delay, or prevent a Purchaser from obtaining JDC. **6. Obligation to Determine If Purchaser Can Purchase JDC in Purchaser's Jurisdiction**  
This product sale is conducted by JustDatingSite, a Lithuanian (EU) company, operating under Lithuanian law. It is the responsibility of each potential Purchaser of JDC to determine if the Purchaser can legally purchase JDC in the Purchaser's jurisdiction.

**7. Acceptance of Terms and Conditions of the Just Dating Coin Sale** As a first step in the purchase process, JustDatingSite will present the Purchaser with these Terms, and associated documents. By placing an order for JDC, the Purchaser: (i) consents and agrees to the Terms; (ii) represents and warrants that the Purchaser is legally permitted to purchase JDC in the Purchaser's jurisdiction and is legally permitted to receive products of Lithuanian origin; (iii) represents and warrants that the Purchaser

is of a sufficient age to legally purchase JDC or has received permission from a legal guardian who has reviewed and agreed to these Terms; (iv) represents and warrants that the Purchaser will take sole responsibility for any restrictions and risks associated with the purchase of JDC as set forth below; and (v) represents and warrants that the Purchaser has an understanding of the usage and intricacies of cryptographic tokens, like BTC, and blockchain-based software systems.

**8. Independent Confirmation of Purchases During the purchase process on the website, JustDatingSite will provide Purchasers with a unique intermediary cryptocurrency address. Using this address, Purchasers can track and confirm that the Purchaser's cryptocurrency has been received at that address and has been subsequently and automatically sent to the escrow address. Knowledge of the unique intermediary address does not constitute a purchase receipt or indicate in any way that any party possessing such knowledge has rights to or ownership of the purchased JDC.**

**9. Receipt of JDC and the Purchase Email As part of the purchase process, and in order to purchase JDC, a Purchaser will need to provide an email address (the "Purchase Email"). The Purchase Email will be used to email the Purchaser a notice of the creation of the Purchaser's account on its website. By purchasing JDC, and to the extent permitted by applicable law, the Purchaser agrees not to hold JustDatingSite liable for any losses or any special, incidental, or consequential damages arising out of, or in any way connected to, Purchaser's failure to secure their account.**

**10. JDC Will Only Be Available For Sale on the JustDatingSite Website JustDatingSite will only sell JDC through the website, available at [ico.justdatingsite.com](http://ico.justdatingsite.com). To the extent that any third-party website or service offers JDC for sale during the initial sale or facilitates the sale or transfer of JDC in any way during the initial sale, such third-party websites or services are not sanctioned by JustDatingSite or its affiliates. As a result, JustDatingSite prohibits the use of these third-party websites or services for the purchase of JDC prior to the end of the initial sale.**

**11. Fraudulent Attempts to Double Spend BTC JustDatingSite will monitor all potential transactions for fraudulent attempts to double spend BTC. Any detected double spend of BTC will result in no JDC being delivered to the associated Purchaser.**

**12. JustDatingSite Will Not Purchase JDC During Initial Sale JustDatingSite warrants that it will not purchase JDC in its own sale. Furthermore JustDatingSite warrants that it will not purchase JDC from any third party, or acquire JDC in any manner, or acquire future control of JDC, during the period of the initial sale.**

**13. Certain Risks Associated with the Purchase of JDC The purchase of JDC carries with it significant risk. Prior to purchasing JDC, the Purchaser should carefully**

consider the below risks and, to the extent necessary, consult a lawyer, accountant, and/or tax professionals prior to determining whether to purchase JDC.

i. It is possible that the value of BTC will drop significantly in the future, depriving JustDatingSite of sufficient resources to continue to operate.

ii. JDC will be stored in a wallet, which can only be accessed with a password selected by the Purchaser. If a Purchaser of JDC does not maintain an accurate record of their password, this may lead to the loss of JDC. As a result, Purchasers must safely store their password in one or more backup locations that are well separated from the primary location. In order to access one's JDC the password that the Purchaser entered is required; loss of this may lead to the loss of a Purchaser's JDC.

iii. Any third party that gains access to the Purchaser's Purchase Email may be able to gain access to the Purchaser's JDC. The Purchaser must take care not to respond to any inquiry regarding their purchase of JDC, including but not limited to, email requests purportedly coming from the website or a similar-looking domain.

iv. Cryptocurrencies have been the subject of regulatory scrutiny by various regulatory bodies around the globe. JustDatingSite could be impacted by one or more regulatory enquiries or regulatory action, which could impede or limit the ability of JustDatingSite to continue to develop their platform.

v. It is possible that JustDatingSite will not be used by a large number of external businesses, individuals, and other organizations and that there will be limited public interest in the use of peer-to-peer currencies for dating site. Such a lack of interest could impact the development of the JustDatingSite Platform. JustDatingSite cannot predict the success of its own marketing efforts or the efforts of other third parties. There is no guarantee of revenues or profits resulting from the marketing activities of the JustDatingSite.

vi. The Purchaser recognizes that JustDatingSite's software is currently under development and may undergo significant changes before release. The Purchaser acknowledges that any expectations regarding the form and functionality of the Platform held by the Purchaser may not be met upon release of the Platform, for any number of reasons including a change in the design and implementation plans and execution of the implementation of the JustDatingSite Platform.

vii. The Purchaser understands that while the JustDatingSite Team will make reasonable efforts to complete the core software, it is possible that an official completed version of the Platform may not be released and there may never be an operational JustDatingSite Platform.

viii. Hackers or other groups or organizations may attempt to steal the BTC and cryptocurrency revenue from the initial sale. To account for this risk, JustDatingSite has and will continue to implement comprehensive security precautions to safeguard the BTC and cryptocurrency obtained from the sale of JDC. Multi-factor security measures will be taken to protect cryptocurrency and JDC including but not limited to physical elements, multi-signature keys, splitting of funds, hot/cold wallet partitioning and diversification. Moreover, regular security audits of hot and cold wallets will be conducted by internal and external teams.

ix. Advances in code cracking, or technical advances such as the development of quantum computers, could present risks to cryptocurrencies and the JustDatingSite Platform, which could result in the theft or loss of JDC. To the extent possible, JustDatingSite intends to update the protocol underlying the JustDatingSite Platform to account for any advances in cryptography and to incorporate additional security measures, but cannot predict the future of cryptography or the success of any future security updates.

x. As with other cryptocurrencies, the Waves blockchain used for the Just Dating Coin is susceptible to attacks. Any successful attacks present a risk to the JustDatingSite Platform and expected proper payment operations.

xi. The loss or destruction of a private key by JustDatingSite used to access may be irreversible. JustDatingSite's loss of access to its private keys or a data loss relating to JustDatingSite could adversely affect the value of JDC.

xii. JustDatingSite Platform is a new product, thus contributing to price volatility that could adversely affect the value of JDC. The factors affecting the further development of the digital assets industry, as well as the JustDatingSite Platform, include:

a) continued worldwide growth in the adoption and use of JDC and other digital assets;

b) government and quasi-government regulation of JDC and other digital assets and their use, or restrictions on or regulation of access to and operation of the JustDatingSite Platform or similar digital asset systems;

c) the maintenance and development of the software of the JustDatingSite Platform;

d) changes in consumer demographics and public tastes and preferences;

e) the availability and popularity of other similar products; and

f) general economic conditions and the regulatory environment relating to the JustDatingSite Platform and digital assets.

xiii. Intellectual property rights claims may adversely affect the operation of the JustDatingSite Platform. Third parties may assert intellectual property claims relating to the holding and transfer of digital assets and their source code. Regardless of the merit of any intellectual property or other legal action, any threatened action that reduces confidence in the JustDatingSite Platform's long-term viability may adversely affect the value of JDC. Additionally, a meritorious intellectual property claim could prevent end-users from accessing the JustDatingSite Platform.

xiv. Cryptocurrency exchanges on which JDC may trade may be relatively new and largely unregulated and may therefore be more exposed to fraud and failure than established, regulated exchanges for other products. To the extent that the cryptocurrency exchanges representing a substantial portion of the volume in JDC trading are involved in fraud or experience security failures or other operational issues, such cryptocurrency exchange failures may result in a reduction in the price and can adversely affect the value of JDC. A lack of stability in the cryptocurrency exchanges and the closure or temporary shutdown of cryptocurrency exchanges due to fraud, business failure, hackers or malware, or government-mandated regulation

may reduce confidence in the JustDatingSite Platform and result in greater volatility in the price.

xv. Political or economic crises may motivate large-scale sales of JDC, which could result in a reduction in the price and adversely affect the value of JDC. Digital assets such as JDC, which are relatively new, are subject to supply and demand forces based upon the desirability of an alternative, decentralized means of transacting, and it is unclear how such supply and demand will be impacted by geopolitical events. Large-scale sales of JDC would result in a reduction in the price.

xvi. It is possible that a digital asset other than JDC could have features that make it more desirable to a material portion of the digital asset user base, resulting in a reduction in demand for JDC, which could have a negative impact on the use and price of JDC. It is possible that a comparable product could become materially popular due to either a perceived or exposed shortcoming of the JustDatingSite Platform that is not immediately addressed by the JustDatingSite Team, or a perceived advantage of a comparable product that includes features not incorporated into the JustDatingSite Platform. If this product obtains significant market share, it could have a negative impact on the demand for, and price of, JDC.

xvii. JDC transactions are irrevocable and stolen or incorrectly transferred JDC may be irretrievable. As a result, any incorrectly executed JDC transactions could adversely affect the value of JDC. Cryptocurrency transactions are not, from an administrative perspective, reversible without the consent and active participation of the recipient of the transaction or, in theory, control or consent of a majority of the processing power on the host blockchain platform. Once a transaction has been verified and recorded in a block that is added to the blockchain, an incorrect transfer of JDC or a theft of JDC generally will not be reversible and there may be no compensation for any such transfer or theft. Such loss could adversely affect the value of JDC.

xviii. Some JDC tokens may be issued on the Ethereum blockchain. As such, any malfunction or unexpected functioning of the Ethereum protocol may impact the Purchaser's ability to transfer or securely hold JDC. Such impact could adversely affect the value of JDC.

xix. Some JDC tokens may be issued on the Waves platform. As such, any malfunction or unexpected functioning of the Waves platform may impact the Purchaser's ability to transfer or securely hold JDC. Such impact could adversely affect the value of JDC.

xx. It is possible that, due to any number of reasons, including without limitation the failure of business relationships or marketing strategies, that the JustDatingSite Platform and all subsequent marketing from the money raised from the same of JDC may fail to achieve success.

**14. All Purchases of JDC Are Non-Refundable ALL PURCHASES OF JDC ARE FINAL. PURCHASES OF JDC ARE NON-REFUNDABLE. BY PURCHASING JDC, THE PURCHASER ACKNOWLEDGES THAT JustDatingSite IS NOT REQUIRED TO PROVIDE A REFUND FOR ANY REASON, AND THAT THE PURCHASER WILL NOT RECEIVE MONEY OR OTHER COMPENSATION FOR ANY JDC THAT IS NOT USED OR REMAINS UNUSED.**

**15. Taxation of JDC and Taxation Related to the Initial Sale JustDatingSite makes no representations concerning the tax implications of the sale of JDC or the possession or use of JDC. The Purchaser bears the sole responsibility to determine if the purchase of JDC with BTC or the potential appreciation or depreciation in the value of JDC over time has tax implications for the Purchaser in the Purchaser's home jurisdiction. By purchasing JDC, and to the extent permitted by law, the Purchaser agrees not to hold any of the JustDatingSite Parties liable for any tax liability associated with or arising from the purchase of JDC.**

**16. Privacy Although JustDatingSite requires that Purchasers provide an email address, JustDatingSite will not publish any identifying information related to JDC purchases, without the prior written consent of the Purchaser. Purchasers may be contacted by email by JustDatingSite regarding a purchase. Such emails will be informational only. JustDatingSite will not request any information from Purchasers in an email.**

**17. Disclaimer of Warranties THE PURCHASER EXPRESSLY AGREES THAT THE PURCHASER IS PURCHASING JDC AT THE PURCHASER'S SOLE RISK AND THAT JDC IS PROVIDED ON AN "AS IS" BASIS WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF TITLE OR IMPLIED WARRANTIES, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE (EXCEPT ONLY TO THE EXTENT PROHIBITED UNDER APPLICABLE LAW WITH ANY LEGALLY REQUIRED WARRANTY PERIOD TO THE SHORTER OF THIRTY DAYS FROM FIRST USE OR THE MINIMUM PERIOD REQUIRED). WITHOUT LIMITING THE FOREGOING, NONE OF THE JustDatingSite PARTIES WARRANT THAT THE PROCESS FOR PURCHASING JDC WILL BE UNINTERRUPTED OR ERRORFREE.**

**18. Limitations Waiver of Liability THE PURCHASER ACKNOWLEDGES AND AGREES THAT, TO THE FULLEST EXTENT PERMITTED BY ANY APPLICABLE LAW, THE DISCLAIMERS OF LIABILITY CONTAINED HEREIN APPLY TO ANY AND ALL DAMAGES OR INJURY WHATSOEVER CAUSED BY OR RELATED TO USE OF, OR INABILITY TO USE, JDC OR THE JustDatingSite PLATFORM UNDER ANY CAUSE OR ACTION WHATSOEVER OF ANY KIND IN ANY JURISDICTION, INCLUDING, WITHOUT LIMITATION, ACTIONS FOR BREACH OF WARRANTY, BREACH OF CONTRACT OR TORT (INCLUDING NEGLIGENCE) AND THAT NONE OF THE JustDatingSite PARTIES SHALL BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES, INCLUDING FOR LOSS OF PROFITS, GOODWILL OR DATA, IN ANY WAY WHATSOEVER ARISING OUT OF THE USE OF, OR INABILITY TO USE, OR PURCHASE OF, OR INABILITY TO PURCHASE, JDC. THE PURCHASER FURTHER SPECIFICALLY ACKNOWLEDGES THAT JustDatingSite PARTIES ARE NOT LIABLE FOR THE CONDUCT OF THIRD PARTIES, INCLUDING OTHER PURCHASERS OF JDC, AND THAT THE RISK OF PURCHASING JDC RESTS ENTIRELY WITH THE PURCHASER. TO THE EXTENT PERMISSIBLE UNDER**

**APPLICABLE LAWS, UNDER NO CIRCUMSTANCES WILL ANY OF THE JustDatingSite PARTIES BE LIABLE TO ANY PURCHASER FOR MORE THAN THE AMOUNT THE PURCHASER MAY HAVE PAID TO JustDatingSite FOR THE PURCHASE OF JDC. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR THE LIMITATION OR EXCLUSION OF LIABILITY FOR CERTAIN TYPES OF DAMAGES. THEREFORE, SOME OF THE ABOVE LIMITATIONS IN THIS SECTION AND ELSEWHERE IN THE TERMS MAY NOT APPLY TO A PURCHASER. IN PARTICULAR, NOTHING IN THESE TERMS SHALL AFFECT THE STATUTORY RIGHTS OF ANY PURCHASER OR EXCLUDE INJURY ARISING FROM ANY WILFUL MISCONDUCT OR FRAUD OF JustDatingSite.**

#### **19. Dispute Resolution**

- a) JustDatingSite and Purchaser (the "Parties") agree to make good faith efforts to resolve any dispute, controversy or claim arising between them relating to this pre-sale and their respective rights and obligations hereunder arising under this Agreement (a "Dispute").**
- b) If the Parties, or their designated representatives, are unable to resolve the Dispute within ten (10) business days after referral of the matter to them, the Parties will submit the Dispute for resolution pursuant to paragraph c. of this Section.**
- c) Except with respect to Disputes concerning (i) the right of either Party to apply to a court of competent jurisdiction for an interim or interlocutory injunction or other provisional remedy to preserve the status quo or prevent irreparable harm or (ii) any Disputes that may arise in connection with a breach of a Party's obligations of confidentiality hereunder, if any Dispute is not resolved pursuant to paragraphs a. and b. above, the Parties will, acting reasonably, agree mutually on the forum for resolution of the Dispute by arbitration as set out in this Section.**
- d) After the completion of the procedures set forth in paragraph b. and agreement by the Parties to enter into binding arbitration in accordance with paragraph c. of this Section, either Party may within thirty (30) calendar days refer the Dispute to arbitration by serving written notice of its intention to arbitrate the Dispute to the other Party.**
- e) The arbitration will be conducted by a single arbitrator to be mutually agreed to by the Parties within three (3) business days following the date of the referral of the Dispute to arbitration.**
- f) The arbitrator will have reasonable expertise and experience in arbitrating commercial disputes involving agreements for the provision of consulting and contractual disputes.**

**20. Force Majeure JustDatingSite is not liable for failure to perform solely caused by: unavoidable casualty, delays in delivery of materials, embargoes, government orders, acts of civil or military authorities, acts by common carriers, emergency conditions (including weather conditions), or any similar unforeseen event that renders performance commercially implausible. If an event of force majeure occurs,**

the party injured by the other's inability to perform may elect to suspend the Agreement, in whole or part, for the duration of the force majeure circumstances. The party experiencing the force majeure circumstances shall cooperate with and assist the injured party in all reasonable ways to minimize the impact of force majeure on the injured party.

**21. Complete Agreement** These Terms set forth the entire understanding between each Purchaser and JustDatingSite with respect to the purchase and sale of JDC. For facts relating to the sale and purchase, the Purchaser agrees to rely only on this document in determining purchase decisions and understands that this document governs the sale of JDC and supersedes any public statements about the initial sale made by third parties or by JustDatingSite or individuals associated with any JustDatingSite parties, past and present and during the initial sale. There are no warranties, representations, covenants, or agreements, express or implied, between the parties except those expressly set forth in this Agreement. This Agreement may only be amended by a written document duly executed by the parties.

**22. Severability** The Purchaser and JustDatingSite agree that if any portion of these Terms is found illegal or unenforceable, in whole or in part, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the Terms, which shall continue to be in full force and effect.
